## **Growers to elect local QSL reps**

Elections are now underway for cane growers in the Mossman, Tablelands, Herbert River, Burdekin, Mackay and Plane Creek districts to decide their local QSL Grower Representative Members.

QSL Grower Representative Members are volunteers who represent their fellow growers with Queensland Sugar Limited (QSL), the state's industry-owned sugar marketer.

Elections for these important roles are held every three years, with nominations for the current elections closing earlier this month.

In eight of the 14 milling regions around the state, the number of nominations received was equal to the number of available positions, and as such, an election is not required. These milling regions and nominees are:

---

- Mulgrave: Jeffrey Day
- Northern (South Johnstone Mill): Barry Stubbs
- Tully: Thomas Harney
- Proserpine: Peter Quod
- Southern (Bundaberg): Allan Dingle & Mark Pressler
- Isis: Peter McLennan
- Maryborough: Jeffrey Atkinson
- Rocky Point: Greg Zipf

**The six milling regions where an election is required are:**

- Mossman
- Tablelands
- Herbert River
- Burdekin
- Central (Mackay)
- Plane Creek

To be eligible to vote in any of the elections noted above, you must be a sugar cane grower who supplies sugar cane under contract to a mill in that region.

To lodge your vote, you must complete the applicable voting paper and return it to QSL by **5pm Friday 17 July 2020**.

Results will be declared by mid-August after votes have been checked and counted by an independent scrutineer. Until such time, current QSL Grower Representatives remain in their positions.
